Roseville Convention Center, Roseville, CA

In addition, pedestrian and bicycle friendly features such as separated sidewalks, internal and external neighborhood linkages, street canopy along with the mixed use components create an active neighborhood center and community gathering place. Burrell is currently working closely with the Sacramento County Department of Transportation staff to re-write the book on roadway design standards for this project. In conjunction with refining the design standards process we are also assisting in requesting and incorporating Caltrans funding for the project.

Community of Locke, County of Sacramento, CA

Principal in Charge - Burrell worked with the Community of Locke, the County of Sacramento, and Sacramento Housing and Redevelopment Agency to process a Tentative and Final Subdivision Map for subdividing this historical community. Our scope of work included working closely with the residents of the town to re-establish historical lines of ownership and change the community from one parcel of rental units into individually owned residential and commercial properties.
